1. F An illegal shift is a dead ball foul **Rule Ref: 2-37, 7-2-6 Penalty**
2. F If one coach goes to the huddle for 30 seconds, another coach may then confer for the time remaining as long as only one coach is in the huddle at any given time.  
**Rule Ref: 2-6, 3-5-8**
3. T An entering substitute is not considered to be a player for encroachment restrictions until he reaches his team's side of the neutral zone.  
**Rule Ref: 2-30-15**
4. F If substitute B12 is on A's side of the neutral zone when the ball is snapped, it is an encroachment foul.  
**Rule Ref: 2-30-15, 3-7-5**
5. T When his team is in scrimmage-kick formation, the snapper is given special protection from a direct charge by an opponent until the snapper blocks or further participates in the play.  
**Rule Ref: 2-30-14, 9-4-6**
6. F Blocking from the rear is always clipping. **Rule Ref: 2-17-4**
7. F The runner cannot commit a spearing foul. **Rule Ref: 2/39**
8. F It is legal for lineman A66 who is outside the free-blocking zone at the snap to block an opponent from behind in the free-blocking zone.  
**Rule Ref: 2-17-3a**
9. T It is a foul to tackle a runner by driving the face mask, frontal area or top of the helmet directly into him. **Rule Ref: 2-41-2, 9-4-2i, j**
10. F A player of B may grasp or hold an opponent in an effort to clear a path for a teammate to get to the runner. **Rule Ref: 2-3-5b, 9-2-3c**
11. F On a free kick from K's 40, the clock should be started when K24 first touches the kick on K's 48.  
**Rule Ref: 2-12-1, 3-3-3, 6-1-6**
12. F If receiver A82 controls the ball in B's end zone, but prior to touching the ground inbounds A 82 Brushes the upright, it is a touchdown.  
**Rule Ref: 2-28-1, 2-4-1**
13. F Illegal participation can be a non-player foul. **Rule Ref: 2-16-2e**
14. T A defensive player is considered to be on his scrimmage line when he is within 1 yard of his line of scrimmage at the snap. **Rule Ref: 2-24-3**
15. T A down ends when the live ball becomes dead. **Rule Ref: 2-7-1, 2-1-2, 4-2-2**
